Description of Works: Plant & Design - Build Contract for Civil and M&E Works of Ruwanwella Water Supply Project

- The Government of the Democratic Socialist Republic of Sri Lanka has received a Loan from the Export-Import Bank of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea in the amount of 20,530,000 US Dollars towards the cost of the Plant & Design - Build Contract for Civil and M&E Works of Ruwanwella Water Supply Project and intends to apply a portion of the proceeds of this loan to payments under the contract named above.
- The Chairman, Standing Cabinet appointed Procurement Committee (SCAPC), on behalf of the National Water Supply and Drainage Board now invites sealed bids from the firms among the Republic of Korea through International Competitive Bidding on Single Stage - Two Envelope procedure as per clause 11 of instructions to Bidders of Bidding Document for the above mentioned Design-Build contract.
- Bidding will be conducted through Competitive Bidding (CB) procedures specified in the Guideline for Procurement under EDCF Loans, and is open to all eligible bidders that meet the following minimum qualifications criteria:
 - The bidder shall be an eligible firm Republic of Korea.
 - The bidder shall have minimum average annual construction turnover of US\$ 17 million calculated as total certified payments received for Contracts in progress or completed, within last Three (03) years (refer Section III, Cl 2.3.2.).
 - The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial resources, other than any contractual advance payments, to meet the cash flow requirement of US\$ 2.2 million for the subject contract (refer Section III, Cl 2.3.3.).
 - Experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least the last Ten [10] years prior to the applications submission deadline (refer Section III, Cl 2.4.1.).
 - Participation as contractor, management contractor, or subcontractor, in at least One (01) design and build contract within the last Ten [10] years, that have been successfully or are substantially completed and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section III Evaluation & qualification criteria (refer Cl 2.4.2. table A and B).
 - Bidders who do not possess design experience in similar projects specified as above in required capacities may enter in to a JV with a design consultancy firm with experience in water treatment, water supply and distribution design.

An additional non refundable fee of LKR 14,000.00 or US\$ 125 should be paid for dispatching the documents by registered air mail.
