The Government of the United Republic of Tanzania has received a loan from the Export-Import Bank of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea toward the cost of the Construction of New Selander Bridge and its connecting Roads and intends to apply a portion of the proceeds for Consultancy Services.

The consulting services ("the Services") include detail engineering design, environmental and social impact assessment, preparation of tender documents, assistance during tender administration; and supervision of the construction works for the New Selander Bridge and its Connecting Roads. The total duration of the assignment is eighty four (84) months inclusive of thirty six (36) months Defects Notification Period.

The Tanzania National Roads Agency (TANROADS), an Agency of the Ministry of Works, now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Eligibility is limited to Korean firms only. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are: Eligibility, Experience on Similar Assignments in the last ten (10) years, experience in similar conditions and availability of appropriate skills among staff related to the assignment.

The short-listing and final selection and employment of Consultants will be in accordance with Guidelines for the Employment of Consultants under the EDCF Loan (the Guidelines) dated March 2005 which is available on the EDCF's website at http://www.edcfkorea.go.kr

Consultants may associate with other firms in the form of a Joint Venture or a sub-consultancy to enhance their qualifications.

A Consultant will be selected in accordance with the Quality Based Selection (QBS) method set out in the Guidelines.
