



## INVITATION FOR SUBMISSION OF EXPRESSION OF INTEREST (EOI) FOR CONSULTING SERVICES



1. The Royal Government of Cambodia (hereinafter referred to as the "Borrower") has committed for a loan from the Export-Import Bank of Korea (hereinafter referred to as the "Bank") from the resources of the Economic Development Cooperation Fund (hereinafter referred to as "EDCF") of the Republic of Korea in the amount of US\$67,434,000 toward the cost of Upgrading the National no. 48 Project (hereinafter referred to as the "Project"), and intends to apply a portion of the proceeds of this loan to payments under the consulting services contract for detailed design and construction supervision for which this invitation to bid is issued.
2. The Ministry of Public Works and Transport (MPWT) as a Project Executing Agency (PEA) on behalf of the Borrower will engage a qualified Korean consulting firm to carry out the services.
3. The scope of the Project is summarized as bellow:

Components	Description
Pavement	Pavement of NR 48 in Koh Kong province (150km) - Asphalt Concrete: Main Road - Reinforced Cement Concrete Intersection area and climbing section
Bridge	Bridge Expansion: 18 ea (301.0m), New bridge: 1 ea (10.0m)
Drainage	New Pipe Culvert: 8 ea (240.4m) Pipe Culvert Expansion: 6 ea (58.0m) Box Culvert Expansion: 2 ea (13.0m)
Consulting Services	Detailed design, preparation and evaluation of tender documents, supervision, assistance in preparation of EIAR, and etc.

4. In order to Implement the Project, the Consultant to carry out the services that will include Detailed design; preparation of tender documents and evaluation report, Management of Contracts and Construction Supervision, assistance in preparation of EIAR and resettlement plan, other services agreed between the PEA and the consultant. The Consulting services are expected to commence in October 2015 and will continue for 42 months.
5. The PEA/MPWT now invite eligible Korean consulting firms to submit an Expression of Interest (EOI) for the above consulting services. Interested consultants must provide their updated company information and experiences in accordance with the Instructions to Applicants Part I that they are qualified to perform the services. Each consultant firm/company shall submit only one EOI in the form of individual company. Expressions of Interest shall be submitted in hard copies together with an electronic copy in CD.
6. Interested consulting firms must obtain the Instructions to Applicants Part I and II upon registration from the address below during office hours from 08:30 to 11:00 and from 14:30 to 16:30 Cambodian local time on Monday through Friday except public holidays, starting from 9 June 2015.
7. The Consultants will be selected among Korean firm/company and the consultant selection will be based on the Quality-Based Selection (QBS) method in accordance with the "Guidelines for the Employment of Consultants under the EDCF Loan".
8. The deadline for the submission of the EOI is not later than 15:00 pm on 9 July 2015 to the address below. Late submission will not be accepted.
9. All firms will be advised of the results of their EOI. Only consulting firms those have been shortlisted will be invited to submit the proposal for the consulting services of the Project.
