

## Invitation for Bid

**Issuing date of the IFB:** August 7, 2015

**Name of Country:** The Federal Democratic Republic of Ethiopia

**Brief Description of Works:** The Project is located in Central part of Ethiopia in Oromia Regional State and starts from Meki, approximately 125 kilometers south-east of Addis Ababa City. The Highway proceeds towards southeastern direction and ends at the outskirts of Zeway. The total length of the project, Lot II (Meki-Zeway Section) is approximately 37km.

**Loan/Credit No.:** ETH-2

1. The government of the Federal Democratic Republic of Ethiopia has received Loan from the Export-Import Bank of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea in the amount of US Dollars 100 Million toward the cost of Construction Works of Design and Build of Modjo-Hawassa Highway Project; Phase I: Modjo-Zeway, Lot II: Meki-Zeway Section (37 Km) (Re-bid) and intends to apply a portion of the proceeds of this loan to payments under the contract for Lot II: Meki-Zeway Section (~37 Km).

**Note:** Bidding will be governed by the Export Import Bank of Korea's eligibility rules and procedures.

2. The Project Executing Agency now invites sealed bids from eligible bidders for Construction Works of Design and Build of Modjo-Hawassa Highway Project; Phase I: Modjo-Zeway, Lot II: Meki-Zeway Section (37 Km). The works contract will comprise the detailed engineering design and construction of 37 km of new 4 lane highway between Meki and Zeway Towns, Construction of roundabouts, overpass and underpasses, and link roads at Meki and Zeway town. In general, each of the 4 lanes will be 3.65m wide with 2m wide paved shoulders. The entire project will be implemented within 40 months after contract signing exclusive of one year defects liability and three years warranty period.

3. Bidding will be conducted through Competitive Bidding (CB) procedures specified in the Guideline for Procurement under EDCF Loans, and is open to all eligible bidders that meet the following minimum qualification criteria:

- The competition will be open only for Korean companies; and
- A minimum requirement for qualification is to have at least two (2) Asphalt Concrete Road Projects within the last eight (8) years from the bid closing date, each with a value of at least US\$ Eighty Two (82) million that have been successfully or are substantially completed (substantial completion shall mean that it must be completed but final disbursement was

not yet made) and that are similar to the proposed works.

A complete set of bidding documents may be purchased by any interested eligible Bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of ETB 900 (Ethiopian Birr: Nine Hundred) or US\$ 50 (US dollars: Fifty). The method of payment will be in cash, bank certified check or telegraphic transfer to the ERA's Bank Account in the Commercial Bank of Ethiopia - Sengatera Branch through Account No. 01715-33144600 Swift Code CBETETAAXX. The document will be sent by registered airmail, but under no circumstances the Ethiopian Roads Authority will be held responsible for late delivery or loss of the documents so mailed.

6. Bids must be delivered by hand or by registered mail in one (1) original and four (4) copies to the address below on or before October 1, 2015. All bids must be accompanied by a bid security of USD 1.8 million. Late bids shall be rejected. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below at October 1, 2015.
