NHIF cracks down on non-compliant employers to recover Sh712m

BY CHRIS MAHANDARA (KNA)

The National Health Insurance Fund (NHIF) has mounted a crackdown on employers who fail to remit statutory de-

ductions.

NHIF Acting Chief Executive Officer (CEO) Dr. Samson Kuhora said the three week exercise targets to net Sh712 million in remittances.

This, he said, was out of

the total Sh1.07 billion the national insurer is owed by employers, dealing a blow on service delivery.

The exercise, he added, aims at sealing the gaps in revenue collection to ensure that operations of the funds

run uninterrupted.

Workers, he said, contribute 64 per cent of the national insurer's revenue adding that measures have been put in place to seal loopholes affecting collections.

Speaking at Tom Mboya Labour College in Kisumu during a consultative meeting with the Central Organisation of Trade Union (COTU) officials, Dr. Kuhora said the move will help clear pending bills and

ensure NHIF beneficiaries continue to enjoy services at all the accredited facilities.

NHIF, he added, was saddened by reports of some

Government steps in to ease sugar shortage with importation option

The Government will authorize the importation of 180,000 metric tonnes of sugar to cushion Kenyans from the skyrocketing prices of the essential commodity.

Ministry of Agriculture and Livestock Development Cabinet Secretary Mithika Linturi noted that the increase in sugar prices has been occasioned by shortage of the commodity in the market.

Speaking at Kilimo House when he witnessed the handing over ceremony between the incoming State Department of Livestock Development Principal Secretary Jonathan Mueke and the outgoing PS Harry Kimtai, Linturi said the sugar will be imported from within and outside the COMESA countries so that they are able to bring the cost of sugar down since local mills are not producing enough sugar.

"Today, because of the sugar shortage, the prices in the market are very high and as a government, we have to take measures to cushion our people the same way we have done in the short-term measures to address the food shortage through the importation of maize and rice," said Linturi.

The CS said that the only way

to bring down the cost of food in the country is people going back to their farms and producing more with the help of the government fertilizer and farm inputs subsidy.

"If we do not revitalize our sugar factories to mill sugar, the shortage will be there permanently," the CS said, adding that there is need to assist farmers to produce more sugarcane so that they support the production of enough sugar in the country.

Linturi said currently, there is no sugar within COMESA and they are being forced to go to countries like Dubai, India and Brazil to get the sugar.

"We thank God that there has been rains and because the farmers that we

registered have taken full advantage of the fertilizer subsidy program, whenever I go across the country, I can see very good food crop in our farms and I am confident that when we get to the month of August we will have a very good harvest," Linturi said.

The CS said his focus currently is to organize the post-harvest and ensure that the grains are properly dried and stored so that whatever is harvested does not go to waste.

beneficiaries being denied services due to the pending bills, cautioning accredited service providers against the vice.

This, he said, was a violation of the contractual provisions the insurer has with the facilities assuring them that all the pending bills shall be cleared.

"We have had engagements with them through the Kenya Health Care Federation and briefed them on the status of payments and the challenges affecting the process," he said.

The delays in clearance of the bills, he added, were occasioned by a dip in the insurer's revenues.

Employer compliance, he said, remained the biggest challenge affecting revenue collections, with medical fraud and gaps in claims processing also dealing a blow to the exercise.

COTU Secretary General Francis Atwoli asked the NHIF board to crack the whip on corruption to safeguard employee contributions. Corruption, he said, remained the biggest chal-

lenge in service delivery, calling for an audit of the accredited health facilities to ensure that only those who meet the threshold are allowed to operate.

Proposed Buildings Control Bill to safeguard construction industry-PS

The Government, through the State Department of Public Works, is drafting a Buildings Control Bill which will regulate the construction industry to ensure the integrity of the built environment and achieve structurally sound buildings.

Speaking at a seminar for architects and quantity Surveyors organized by the Boards of Registration of Architects and Quantity Surveyors (BORAQS) in Nairobi, the Principal Secretary Mr. Joel Arumonyang noted that the new piece of legislation will ring fence the building industry from quacks posing as quantity surveyors and architects and ensure cases of buildings under construction collapsing are minimized.

BORAQS is a regulatory institution domiciled in the State Department for Public Works under the Ministry of Lands, Public Works, Housing and Urban Development.

It is mandated to regulate the professions of architecture and quantity surveying

through training, registration and development of ethical practice guidelines.

Mr. Arumonyang revealed that Board of Registration of Architects and Quantity Surveyors (BORAQS) has churned out the newest bunch of professional Architects and Quantity Surveyors during its 10th graduation ceremony held at Nairobi.

The graduation was a culmination of a two-day Continuous Professional Development (CPD) Seminar.

“As a State Department, we will go out of our way to put the necessary legislative safeguards in place to ensure that the building industry upholds all professional standards and keep quacks at bay”, said the PS.

The seminar whose theme was “The Built Environment and Climate Change; Achieving a Sustainable Built Environment”, brought together stakeholders in the construction industry from both Kenya and the larger East African Region.

Gov't to open security roads in Shakahahola for rescue operations

The Government has commenced an exercise of opening security roads within the Shakahahola forest in Malindi sub county to help search and rescue teams conduct their operations efficiently and smoothly.

Interior and National Administration Cabinet Secretary Prof Kithure Kindiki (Pictured) said, the new and extra routes will hasten the search for missing persons who are still alive and hiding in the expansive forest and help search teams to easily identify grave sites.

Prof. Kindiki at the same time said, more graves had been discovered within the 800-acre land believed to belong to controversial cultist and preacher, Paul Mackenzie where 241 victims of the preacher's cultic teachings have so far died. The CS launched the second phase of post-mortem on 129 bodies of Mackenzie's victims at the Malindi Sub County Hospital Funeral Home.

He said the Government would scale up the security operation within



the 50,000-acre Chakama ranch and beyond by employing the use of satellite technology, drones and aircraft to search the entire ranch and in neighbouring Tsavo East National Park and the Kulalu Ranch.

“We have started opening several security roads effective immediately in order to search every millimetre of the Chakama Ranch for any survivors of Mackenzie's atrocities,” he said at the Shakahola Command Centre, after visiting officers involved in the search and rescue operation. Kindiki visited Mr. Mackenzie's alleged home inside the 800-acre farm among other areas before holding the press briefing.

He said more graves, including close to ten mass graves, had been discovered and would be dug up

to exhume the bodies after the second phase of the post-mortems.

The CS, who was accompanied by Kilifi Governor Gideon Mung'aro and other senior government officials, said it was not easy to identify the graves as some had been tampered with by the perpetrators, while others had been concealed with vegetation.

“Even the exercise of looking for graves we believe is not complete because some of those graves are not conspicuous. Some of them were tampered with while others have been concealed by growing vegetation on top of them,” he said.

He said the search and rescue operation would not be interrupted and that 24-hour surveillance would be put in place and more personnel and modern technology that include the use of satellites to enhance communication.

He said he had asked the Communication Authority (CA) and the Directorate of Criminal Investigations (DCI) to pull down Mr. Mackenzie's cultic teachings on social media.

NTSA to work with counties to enhance road safety response plans

The National Transport and Safety Authority (NTSA) is working with county governments and other stakeholders to set up road safety response plans and committees that will help improve road safety in counties.

Speaking during a three-day road safety workshop in Naivasha, NTSA Director General (DG) Mr. George Njau said the organisation has started off with ten counties traversing the Mombasa - Malaba highway because of the high number of road accidents which are reported on this highway

every year.

The workshop, which is sponsored by the European Union (EU) was attended by County Executive Committee Members (CECM) from the ten counties of Mom-

basa, Makueni, Machakos, Kajiado, Nairobi, Kiambu, Nakuru, Kericho, Kisumu and Kakamega where most road accidents have been reported along the Mombasa - Malaba highway.

Mr. Njau said the ten counties will be assisted to adopt non-motorized means for road users such as construction of pedestrian walks and capacity building for motor-cyclists, popularly known as boda boda and road safety sensitization among other road safety measures.

He said the initiative which is part of the larger road safety campaigns known as 'Usalama barabarani' which was started five years ago, will later be expanded to cover other counties and added that the programme had borne some fruit. "The counties will also be required to set up some funds for road safety programmes which include road safety campaigns and awareness for road users. For instance, this financial year, Nairobi County has set aside Sh750million for this purpose," the NTSA Director General said.

Rono recognized the challenges faced by Kenya's public finance, referring to the country's national debt portfolio approaching the debt ceiling of Sh10 trillion and acknowledged the need for proactive participation from accountants to address the current fiscal situation and contribute to the economic growth of the nation.


Additionally, the PS called for a strategic and holistic perspective among accountants, encouraging them to transcend their traditional bookkeeping roles

and embrace a broader responsibility.

"Accountants should not limit themselves to mere financial record-keeping. It is crucial for them to consider the future trajectory of their organizations and work towards sustainable economic, social, and environmental goals. By allocating resources to impactful areas and providing accurate financial information, they can enhance decision-making processes and drive overall growth," noted Ms. Rono.


Addressing the transformative power of technology in the profession, the PS stressed the need for accountants to embrace continuous improvement and stay updated on technological advancements.

"Technological advancements are reshaping the accounting profession. Accountants need to adapt and leverage these advancements to enhance their capabilities and improve efficiency," she said.

Kenya takes stride towards gender equality with National Care Policy

The Government through the State Department for Gender and Affirmative Action has initiated the development of the National Care Policy which is expected to provide a comprehensive framework for addressing unpaid care work in the country.

Statistics reveal that women perform 76 per

cent of all unpaid care work spending four to five hours per day against one hour for men, shining a light on the gender inequal distribution of unpaid tasks within the sphere of unpaid care work.

The proposed National Care Policy will cater to the disproportionate burden that unpaid care work has on women.

Speaking during the

policy drafting consultative meeting, the Principal Secretary for Gender and Affirmative Action, Ms Veronica Nduva said the National Care Policy is designed to recognize and value unpaid care through the provision of public services, infrastructure and social protection policies and the promotion of shared responsibility within the

household and the family as nationally appropriate.

“Unpaid care work is a major barrier towards the achievement of gender equality and women economic empowerment.

The available evidence has accelerated the need to engage all key stakeholders to formulate a national intervention to address care work initiatives,” said PS Nduva.

Research indicates that care work comprises all activities essential for the day to day physical, psychologi-

cal and emotional well-being of people.

PS Nduva noted that the disproportionate responsibility for the unpaid care work results in time poverty and significant opportunity costs particularly among the poorest and most marginalized women and girls.

“Heavy and unequal unpaid care work undermines women and girls’ rights by excluding them from opportunities to engage in decent paid work, education and political life and leisure activities.

The proposed project will traverse eight counties (Mombasa, Kwale, Kilifi, Taita Taveta, Makueni, Kajiado, Machakos and Nairobi).

"My Ministry, through the Directorate of Children's Services, is currently

developing guidelines to support initiatives that can prevent and address issues of missing children. I therefore urge the Directorate to fast-track this process which should adopt a multi-sectoral approach," she said.

The CS urged community members to provide information for missing children through various channels that the government has put in place including: the child helpline 116; Missing Child Kenya hotline - 0800 22 33 44 999; and the DCI toll-free crime reporting hotline 0800 722 203.

She urged stakeholders to continue raising awareness on such cases of missing children.

MCK collaborates with counties to weed out quacks posing as journalists

Quacks posing as journalists will soon have nowhere to hide if a proposal by the Media Council of Kenya (MCK) to rope in county governments to weed out such individuals' sails through.

North, Eastern and Central Media Council of Kenya (MCK) Regional Coordinator Jackson Karanja says, discussions between the Council and county governors are at an advanced stage to come up with stringent measures which will ensure only accredited journalists are allowed to cover government functions.

In the proposed sweeping changes, which may finally address the menace posed by quacks who infiltrate important public functions and even end-up misreporting facts, Karanja noted that journalists will now have their accreditation cards scanned at a common desk before they are allowed to cover any such functions.

Karanja says unlike previous accreditation cards that

lacked tamper proof security features, the Council is now issuing cards with special bar codes embossed with an individual vital details and a unique number.

"The previous accreditation cards did not have a QR (Quick Response) code and therefore, anyone could come up with one.

"So, what we are doing as an institution to mitigate this challenge is to have journalists who have this card -with a QR code, access county government and county assembly functions.

"It is something we are doing and which is ongoing and we want to start at the very basic level. Only journalists who have accreditation cards that can be

scanned to show where they work will be allowed access to government information," said Karanja, during a courtesy call of the Nyeri County Information Office.

The official further said

the Council had also received complaints of rogue journalists storming public functions while under the influence of alcohol, and conducting themselves in unbecoming manner before the full glare of cameras.

He added that they are in the process of conducting training for media practitioners on the need to uphold the tenets and ethics of professionalism as espoused in the Code of Conduct.

"We are telling accredited journalists to be professionals and conduct themselves with decorum. Be different from quacks. Cases of journalists coming to functions drunk portray a bad image for the profession," he added.

The official similarly said the Council is also partnering with the Communication Authority (CA) in a bid to inject professional standards of reporting by media houses to ensure those responsible for managing such entities are people who have undergone proper training in matters of reporting.

Experts stress research to mitigate effects of climate change

Researchers, academicians and senior government officials are of the opinion that evidence-based research and proper land management are key in mitigating adverse effects of climate change in the country. The researchers said that the recent prolonged drought and floods that had affected over five million people in the country causing loss of livelihoods and acute food security can be addressed through evidence-based research that gives effective solutions. The researchers, academicians and the government officials were speaking during the 2nd Regional Research Conference on Land and Natural Resources themed 'Responding to Climate Change through Land Governance in the Region' held at the Kenya School of Government, Nairobi.

The two-day conference will generate policy recommendations to support

mainstreaming of climate action and access progress on carbon trading in the region, as well as collaborate, synthesize and share knowledge related to land governance and climate change adaptation, mitigation, capacity building and technology with relevant stakeholders among others.

In concurrence, the Cabinet Secretary for Education Ezekiel Machogu said his ministry is implementing the School for Carbon Offset Project to reduce greenhouse emissions in learning institutions.

Machogu who made the remarks at the conference in a speech read on his behalf by the Principal Secretary for Basic Education Dr. Belio Kipsang, said the climate-focused project will contribute towards the realization of Kenya's nationally determined contribution of reducing emission by 32 per cent 2030.

the high seas. Such include seafarers, maintenance units, navigation teams and hospitality.

There are also land-based jobs in ports, docks and landing bays for ground crew, workers in Container Freight Stations (CFS) and landing zones for fishing trawlers. There is also establishment of ponds for fish farming inland amongst other opportunities.

Kenya, according to the

PS, has lagged behind in tapping the potential in the ocean despite the fact that 80 per cent of the international trade occurs across the oceans. One sector where Kenya is performing dismally in the maritime sector is on the seafaring front.

Global statistics indicate there are approximately 1.6 million registered seafarers. Africa has 76,000 seafarers. Kenya has a paltry 6,000 seafarers working for shipping lines. This number is negligible compared to countries like Philippines which has over 200,000 seafarers; a marine workforce that injects over Sh950 billion annually in their country as forex from salaries and other allowances paid to the seafarers.

“We are talking about very attractive returns when we talk of the blue economy,” said the PS in Mwatate during a meeting with hundreds of youths from the region in a multi-sectoral symposium to discuss the opportunities offered by the blue economy sector.

State to establish robust cybersecurity risk mitigation framework

The Government will soon establish an elaborate risk mitigation framework to handle cybersecurity matters in the country.

Speaking during the Annual General Meeting of ID4Africa held in Nairobi, the Cabinet Secretary for Information, Communications and The Digital Economy Eliud Owalo noted that in the process of digitalisation and adoption of a digital identity, measures will be put in place to handle cybersecurity matters.

“In this regard, the government has established and operationalised the Office of the Data Protection Commissioner which is charged with ensuring we have got adequate levels of data privacy and correspondingly data security,” said the CS.

CS Owalo further revealed that the govern-

ment has also put in place a multifaceted team consisting of integral segments to ensure that as the country digitalises, they are correspondingly, analysing the emerging trends of cyber-security globally.

He added that the team will also be checking what other countries are doing so that Kenya can benchmark global best practises in cyber-security and customise them to meet “our own situation.”

The CS said that the government will back the establishment and implementation of a proper policy, legal and regulatory framework to ensure success of digitalisation and adoption of digital identity for the country.

He added that policies and laws should be consistent for efficacious rolling out of projects in the country.

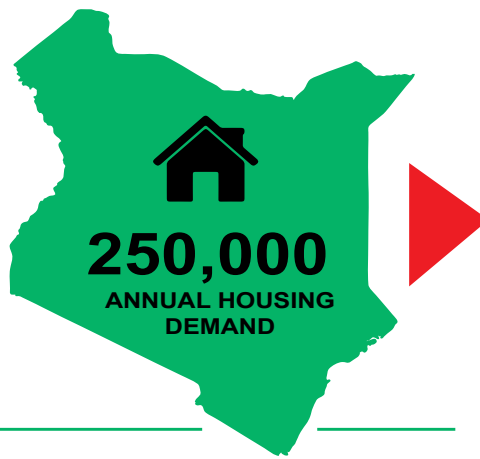

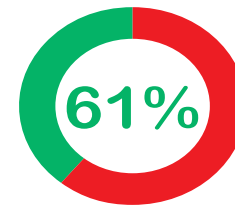

1. What is the Affordable Housing Program?

The Affordable Housing Program (AHP) is an initiative by the Government that targets the delivery of decent and affordable housing to low and middle-income households.

2) Who will build the Affordable Houses?

The Affordable Houses will be financed and built by private developers on both public (national and county) and private land across the country.

3) What are the target segments of the AHP?

The Affordable Housing Program is intended to address the housing needs of the following income brackets:

1. **Social - Up to KES 14,999**
2. **Low Cost - KES 15,000 - KES 49,999**
3. **Mortgage Gap - KES 50,000 - KES 100,000**
4. **Middle to High Income - KES 100,000+**

Given that these income groups form the bulk of the housing market, the AHP aims to provide them with accessible and standard living spaces. The goal is to promote human dignity and goes a long way in establishing and promoting social equity.

4) What is the Government's role in the AHP?

The Government's main role is primarily that of a facilitator that aims to create an enabling environment for a private sector-led solution that will ensure that the ambitious and capital-intensive project becomes a reality. This will be done through several interventions such as:

1. Provision of state-owned land
2. Delivery of bulk infrastructure to the sites where the housing units are earmarked for development; including access roads and transportation network, power, water, and sewerage
3. One-stop-shop to streamline and fast-track statutory approvals; including transfer of titles and architectural drawings, amongst others
4. Offering tax incentives: Registered persons will be eligible for a tax credit equivalent to the lower of 15% of gross emoluments or the actual savings subject to a limit of KES 9,000 per month. Self-employed persons who register as members are also eligible for the tax credit. Voluntary Savings will attract the same tax relief. For employed persons, the employer will incorporate the deductions and tax credit in the payroll, while the self-employed persons will take credit when computing their tax liability. The Government will also waive stamp duty for first-time homeowners;
5. The Government is also working at other legislative and policy reforms required to level the playing field further
6. The Government has also produced and published the Development Framework Guidelines, which provide qualitative guidance on how the AHP will be implemented, how projects will be prioritized and programmed, and how developers/investors will be engaged. It further addresses the financing framework, the urban and building design standards, environmental and social safeguards, as well as other important elements of the project delivery framework
7. The development strategy for the AHP also integrates quality assurance and oversight as projects are being developed. The Government will ensure that the standards articulated in our laws and the DFGs are adhered to.

5) The affordable housing program incorporates supply, demand and enables environment interventions.

Supply side:

1. proven demand master plan and megacity approach
2. mixed-use developments with the provision of social infrastructure and amenities
3. affordable housing financing

Enablers:

1. Provision of land and bulk infrastructure
2. Infrastructure funding under KUSP
3. Tax incentives
4. Tax breaks (Zero-rating of stamp duty) for first-time owners
5. Standardized designs and processes

Demand side:

1. Tenant Purchase Schemes (TPS)
2. Kenya Mortgage Refinance Company (KMRC) - extending Mortgages tenures and lowering interest rates

3. Housing Portal to assist in aggregating demand for offtake of the units.

6) What is the Housing Fund?

The Housing Fund is a Fund established under the Housing Act with an aim of delivering affordable housing to Kenyans. The Fund will therefore play a critical role in overcoming the inefficiencies in the housing sector that have led to the housing deficit in the country. This will entail interventions addressing challenges faced from both the supply and demand side of the sector.

The Housing Fund will mobilize private sector investment in the program in order to achieve its objectives. In addition, the Housing Fund will also work with Development Finance Institutions (DFIs) and other development partners to raise the required funding for the projects

Through the partnerships, the Fund will aggregate demand and link it to the supply from developers. Affordability and access to competitive financing for homeowners will be secured by addressing tenure and interest rates through the Tenant Purchase Scheme (TPS) model. Owners will be able to make payments over a 25 - 30 year period with financing of less than 10% thereby reducing expected monthly payments to manageable levels as well as a possibility for multi-generational mortgages.

7) What guarantees are there to ensure that the Fund is run prudently and efficiently?

The Housing Fund as established by the Housing Act is under the control of the National Housing Corporation (NHC) and is thus fully anchored in law. It is institutionally embedded to ensure that we safeguard public funds and that the Fund is managed diligently and transparently. Section 7 of the Housing Acts spells out the administrative guidelines and governance structure that the NHC should adhere to so as to ensure the Fund's autonomy and protect it from manipulation and misappropriation.

The NHC has set up a governance structure comprising of fund custodians to maintain the assets and asset titles of the Fund, a fund administrator to manage the day-to-day operational affairs of the fund, and a fund manager to direct the fund investments. This structure ensures there is no concentrations of risk, and that the assets of the fund are safeguarded.

8) How does AHP differ from other housing schemes in Kenya?

The AHP differs from other housing schemes in Kenya. It is the first comprehensive program in which the Government of Kenya seeks to use private sector funding to facilitate the provision of homes to Kenyans in the lower- and middle-income brackets.

B. APPLICATION PROCESS

1) Where and how do I apply to buy an Affordable house?

Individuals interested in buying Affordable Houses under AHP will first have to register on the Boma Yangu housing portal, either online or through the *832# USSD. Upon registration an account will be automatically created for the member. This will enable you to begin contributions to the Housing Fund and saving towards your own home. You will then also be able to select your housing preference from the available or upcoming housing stock. Once registered and contributing to the Housing Fund, applicants who qualify will participate in a regular and transparent allocation process for the available houses.

2) Is there a fee to apply?

There is no fee for applying. It is absolutely free. To activate your account, you will have to make a saving of KES 200.

3) What do I need to qualify?

All applicants will need to be a citizen of Kenya with a valid national ID number.

(Please note that you have to have an e-citizen account.)

4) Do I have to wait for 5 years to be allocated an Affordable house?

No. Members who register on the affordable housing portal and begin making Savings and qualify for affordable housing will be allocated a house as soon as developers begin constructing affordable houses.

5) How will the houses be allocated?

The houses will be awarded through a fair and transparent system, on a "first past the post" basis, free of any human intervention and contact.

C. ALLOCATION OF HOMES

1) Is the allocation system a form of betting?

No, the allocation system is not betting. It is a fair and transparent system that allocates houses to qualified applicants, as indicated above.

Members will be asked to indicate their preferred location (by county) of a house and then be provided with information on the type of home they qualify for based on their income and required deposit payments.

Homes will be allocated on a first come-first served basis, based on the time when members qualify for allocation meaning they have a full profile (100% complete), they have selected which home they would like to buy, and they have saved the required 10% deposit.

Potential owners will be selected from this waiting list of registered pre-qualified, eligible applicants.

Allocation processing will be announced on the Housing Portal and through other communication outlets.

Allocation will only be carried out for projects that are going live and whose construction has begun.

The weighted pre-qualification criteria will include factors such as income, household status (priority to families), current assets owned, vulnerable groups, accumulated deposit, first come - first serve basis.

Concerning social housing, we will work with settlement executive committees representing community interests and ensuring that those living in the community are beneficiaries. This will entail registration, enumeration, and verification of the community members.

2) What happens if I qualify for a house but do not get allocated one?

The system is designed to ensure every qualifying applicant is allocated a house. However, it is expected that there will initially be more demand for houses than the supply of affordable houses. If an applicant is not allocated a house in an initial allocation, their name will be put on a waiting list, and the applicant will have a higher likelihood of allocation on subsequent developments.

3) Can I be on a waiting list and for how long?

Yes, the waiting list ensures that those who might have missed out on an initial allocation get priority.

D. DESIGN AND PROJECT INFORMATION

1) What type and size of houses are offered under AHP?

The AHP homes will comprise houses ranging from one-bedroom to three-bedroom units with varying sizes depending on the locations and the needs analysis. The unit typologies are as follows:

One Bedroom	20 sqm	KES 1,000,000
One Bedroom	30 sqm	KES 1,500,000
Two Bedroom	40 sqm	KES 2,000,000
Three Bedroom	60 sqm	KES 3,500,000

For Social Housing, the typologies are as follows:

One Room	KES 600,000
Two Room	KES 1,000,000
Three Room	KES 1,400,000

To enhance affordability, the program caps the maximum selling price of the housing units as indicated above.

From time to time, the unit sizes may change depending on the project site and other relevant development factors.

2) Will there be houses in the rural areas?

Yes. The AHP is a nationwide program that also seeks to transform millions of Kenyans who live in rural areas. The Government will continue to support homeowners to build houses that fit into the local environment and utilize locally available building materials. One of the major challenges of housing in rural areas is the quality of building materials.

To address this, Appropriate Building Technology (ABT) centers have been constructed across the country. We are looking to put up more in every constituency and eventually wards across the country. These will offer technical assistance and equipment to the members of the public to improve the quality of their houses.

This initiative aims at addressing the housing needs of various communities in a cost-effective and environmentally sustainable manner. We have also partnered with TVET colleges to train members of the public on how to use these technologies and also how they can modernize construction practices while preserving cultural values. We will also make available for hire Matofali machines used to manufacture stabilized soil blocks. The result will be creating thousands of new jobs that will improve their quality of life and reduce rural-urban migration. Rural housing funding will be available from NHC at an interest rates of 13%.

3) How will I know if there is an upcoming project in my desired location?

Regular and timely updates on upcoming projects shall be given on the Boma Yangu housing portal and other platforms such as daily newspapers, radio, and at your nearest Huduma Center.

4) Who will manage the services within affordable home projects?

The AHP anticipates that facilities management will be critical for ensuring that communities remain livable in the long term. Under the current delivery framework, homeowners will be required to pay an affordable service charge towards the upkeep of common facilities. A portion of this service charge will go towards a sinking fund for major repairs within a housing complex.

Facilities management will be contracted to companies specializing in these services.

5) What is a Boma Code?

All Projects on Boma Yangu will have a special code (Boma Code) applied on the specific types of units available. Boma Codes will make it easy to select a preferred unit through the USSD channel.

E. TARGET BENEFICIARIES

1) Do I have to be low-income or a first-time homebuyer to benefit from the Affordable Housing Program?

The AHP mainly targets Kenyans in the low and middle-income brackets who have previously been excluded from owning decent homes due to the prohibitive costs and stringent financing requirements. The program seeks to make affordable housing available to all Kenyans by lowering the cost of financing homeownership. The KMRC will provide liquidity and longer-term financing to Kenyan banks and SACCOs in order to increase the volume, the tenor of residential mortgages, and availability of fixed-rate mortgages. This is expected to improve the affordability of mortgages, increase the number of qualifying borrowers, and expand the primary mortgage market and homeownership in Kenya.

2) Is there an age limit to qualify?

Applicants will have to be at least 18 years of age.

3) For Kenyans earning more than Kshs 150,000, will they be included in the program, and if so, how?

Since this is a government-backed affirmative program, priority will be given to individuals within households earning less than KES 150,000. The KMRC introduction aims to lower interest rates on mortgages to be low current market rates. This will be accessible to all customers, including those earning over KES 150,000.

4) Are civil servants eligible to participate in this program?

Yes. There are opportunities for civil servants to own homes under the AHP. Therefore, they are encouraged to register in earnest and take advantage of their house allowances to get a better house.

F. SAVINGS AND CONTRIBUTIONS

1) Can I contribute over and above the amounts required under the law?

All Savings to the Housing Fund are entirely voluntary. There are no caps on Savings

2) Can my spouse and I contribute to our house?

Yes. Spousal and joint Savings can be made towards the ownership of one house at a time. However, there is still an option to apply for a house individually. Collective Savings increase that couple's chances to get their house within a shorter time.

3) How can I make my Saving into Boma Yangu?

Upon registration on Boma Yangu, log into your account, click on "save now". This will allow you to save to your account using Mpesa. The Mpesa paybill number is 005500.

You can also contribute to your account by making a deposit through any of the authorized collection banks. The list of participating banks and agencies will be published on the AHP website at www.bomayangu.go.ke.

Be sure to provide your national ID number while making the Saving into physical banks. This will assist with ensuring the amounts are credited to your account.

4) Will I be able to monitor my Savings?

Yes. Members will be able to monitor their savings via the individual account created on Boma Yangu housing portal.

5) Does Saving mean getting a house?

In the long term, yes. As you contribute and build your savings up to 12.5% of the total value, you eventually get allocated a house or remain on the waiting list - and ultimately, you get your home as projects complete development.

6) Can I withdraw my voluntary savings at any time?

One can apply for withdrawal of Savings through the Boma Yangu portal. This process requires review and approval. The Housing Fund Regulations provide that one can withdraw their savings after seven (7) years

7) Why should one be deducted transaction fees when making a payment?

Transaction services providers' fees will apply.

8) If a transaction does not go through or customer reverses the amount, what is the process of retrieval?

For payments made through mobile money transfer, the customers will contact the service provider and initiate a reversal. For payments through financial institutions, they will contact the specific banks/institutions and initiate reversal.

9) What happens if my Saving does not reflect on my account?

Contact the Huduma Call Centre for customer support or write to enquiries@bomayangu.go.ke - with proof of payments such as a confirmation message or deposit slip.

G. TENANT PURCHASE SCHEME

1) How much will I be required to pay and for how long?

The amount payable for the house will depend on the type of house selected and allocated. The monthly payments will be determined after taking into account the amount of deposit paid and the desired payment period. The typical payment period will be between 25 to 30 years.

2) How frequent will the payments be?

The payments shall be made monthly.

3) Will the payments increase over time?

No. The payments will be fixed over the life of the financing.

4) How many houses can I buy?

A member is only entitled to one house under the Affordable Housing Program.

5) Can the Housing Fund help me get a loan to purchase a home?

Yes. The Housing Fund will facilitate long-term affordable financing to members that qualify and are allocated an affordable house under a long-term Tenant Purchase Scheme or mortgage finance.

6) Can I buy a house if I have no credit history or regular income?

Yes. However, the applicant will have to prove that they can make their regular monthly loan repayments.

7) If I fall behind in my payments, will I be able to keep my home?

The payment terms are designed to be affordable and flexible, geared towards helping you secure your home. However, every case will be looked at on a case-by-case basis.

8) Are there restrictions on the sales of the houses?

Yes. A member cannot dispose of their house to the open market before seven (7) years have lapsed. However, before the seven (7) years are over, they have the option to sell it back to the Housing Fund and retain their equity build up.

9) How can I meet with an advisor to guide me further?

Information and guidance shall be provided through official communication channels on the State Department for Housing and Urban Development website, on social media platforms and on the Boma Yangu portal.

10) Are incomes assessed individually or as a household?

Incomes will be assessed either individually or jointly depending on if the application is made individually or jointly. If an application is made jointly, the house title will be issued in the name of all the joint applicants.

11) What is included in the income?

Income includes any income sources whether regular or irregular.

12) What happens in the event of death?

In the event of death, the housing unit can be transferred to the registered next of kin.

H. MORTGAGES

1) Does mortgage pre-qualification apply to everyone?

Mortgage pre-qualification is available to all members seeking to finance the purchase of their homes using mortgages..

To submit documents for pre-qualification for a mortgage, log into your Boma Yangu account. Click on "Mortgage Prequalification" and submit the required documents

2) What are the steps of accessing a mortgage? What arrangements are in place for members interested in mortgage facilities?

The mortgage option is a method of payment for a housing unit. Once you have saved the required 10% deposit and have been allocated house, you will be required to provide a payment plan for the balance. You can seek a mortgage or loan or payment plan from our partner banks or other financing institutions. The bank or financing institution on the execution of mortgage facility will then deposit the funds in the designated institution as indicated in the sale agreement.

3) What is the rate for the mortgage, and which financial institutions are you in partnership with?

The rate of the mortgage varies depending on the financial institution. SDHUD cannot influence the mortgage rates for financial institutions. However, for institution working in collaboration with KMRC the target is to provide mortgages at a rate less than 10%.

I. REFUNDS

1. How long before one gets their refund, and is it the principal amount contributed?

The timelines on refunds will soon be published on the Boma Yangu site, and we will update the public in due course.

2. Can one have their Savings refunded if they have changed their mind?

Yes, one can have their Savings refunded.

3. Procedure for refund application on Savings

A standard form and instructions to apply for a refund have been provided on the Boma Yangu website, <https://bomayangu.go.ke/>

4. Is the 15-year refund period for Savings still valid?

Refunds will be guided by the Housing Fund regulations and will be made available upon submission of a request.

J. OPPORTUNITIES

1. Are there opportunities for Kenyans, particularly those in the informal sector, to participate in the AHP?

The AHP is intended to provide benefits beyond the delivery of affordable homes. The construction of the units is expected to create direct and indirect employment opportunities for Kenyans. These will include opportunities for skilled and unskilled labor. We estimate that for every unit constructed, 3 - 5 new jobs are created.

The AHP will create the much-needed opportunity to formalize the informal sector. Ring-fencing strategies will be implemented to ensure that the Jua Kali sector (local artisans and other professionals such as plumbers, electricians and AGPO) can make investments and supply inputs to the affordable housing program. This will include different strategies for standardization of inputs such as windows and doors. Light industries will also have the opportunity to provide construction materials such as cement.

Other opportunities will be in facilities management. It will be ensured that common property infrastructure and services are of high quality and functionality consistent with the level of physical, social, aesthetic, and economic amenity provided by the property at the beginning of the development's occupancy.

The size of the developments under the Affordable Housing Program will be significant. It is anticipated that during the program's implementation, there will be a rise in the consumption of the various building materials that are locally manufactured.

K. ABOUT THE HOUSES

1. Where are the exact locations of the houses and the land where the house is built?

Projects will be countrywide, and the initial phases are as follows: <https://www.bomayangu.go.ke/projects>

2. What is my freedom when I own the house? What is the proof of ownership when one possesses the house since it stands on government land?

Once fully paid, you have the freedom of any other homeowner. The proof will be a sectional title.

You own the house even if it has been built on Government land, as long as you have completed payment.

3. What are the criteria of payment, full or partial?

There are several categories of buyers':

- Mortgage buyers. You are servicing your payment for the entire period of the mortgage.
- Cash buyers. As per the purchase contract.

Each of the above will have different requirements for determining full payment.

4. Do all occupants get equal rights to payment of the units, e.g., disabled, widows, and widowers?

Yes

5. Is the pricing of the units the same in all counties?

The pricing per unit may vary from one geographical location to another. However, because this is an affordable housing project, the unit cost will be significantly lower than the prevailing market value in that region.

"This conference targets at least 1000 delegates and 200 exhibitors from governments at international, national and county levels, Water Utilities, Water Associations, Government Agencies, Environment, Energy, and Agriculture, Research institutions, Private sector, Academia, Development Partners, Foreign Missions, Civil Society, NGOs, Consultants, Service Providers and Financial institutions", PS Rono said.

Participants and partnerships are drawn from Water Service Providers (WASPA), Ministry of Water, Sanitation and Irrigation Council of Governors (CoG) and County Government of Mombasa.

ing programme is going to be private sector led. You are all aware that the private sector are able to mobilize both human as well as financial resources to complement the work of government," CS Tuya said.

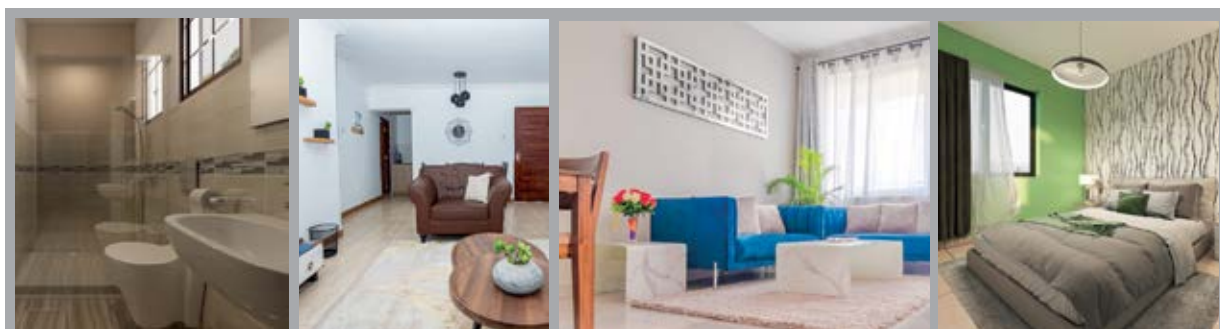
The Cabinet Secretary said her Ministry had adopted a whole-of-society approach in tree growing initiative and outlined the progress made to-

SAVING

- Upon registration, a home applicant can save any amount in their boma account via USSD or the web portal
- Savings are on a voluntary basis and has no cap
- Mandatory contributions, when enacted, will also be recorded for those in formal employment
- Home applicants can apply to get their savings refunded should they wish and in line with the provisions of the Housing Fund Regulations



SELECTING YOUR PREFERRED UNIT

- Home applicants can browse through affordable Housing projects from various counties and either add them to their wishlist or select a preferred unit
- Selecting a preferred unit means that the home applicant's savings will count towards the 10% deposit required before they can qualify for allocation



HOME DEPOSIT AND ALLOCATION

- After a home applicant saves an amount equal to the deposit (10% of the preferred unit) they proceed to allocation
- Allocation is fair and transparent, based on a "first past the post" basis. Note that home applicants not allocated a house due to demand will be added to a waiting list and prioritised for subsequent allocations



HOME FINANCING OPTIONS

- Home applicants can enjoy home financing options through the Boma Yangu portal.
- Home applicants can access subsidized home loans (single-digit interest rates) by submitting a single mortgage form shared across multiple financiers for pre-qualification.
- Home applicants may access the Tenant Purchase Scheme (TPS) which enables homeowners to make payments for their homes as rent over an extended period (up to 30 years).



HOME OWNERSHIP

- Upon successful allocation, home applicants receive a letter of offer.
- Upon acceptance, the home applicant makes a choice, based on the available options, on how to pay off the balance
- For outright purchase (cash sale) or upon getting prequalified for a mortgage, the home applicant will sign a sale agreement
- Home applicants that qualify for TPS will sign a TPS agreement.
- Homeowners will receive the deed and be able to occupy their home upon practical completion of the project

NHIF Sh6.9b preventive healthcare package to focus on early detection and management of diseases

The National Hospital Insurance Fund (NHIF) has sought Sh6.9 billion from the National Treasury to roll out a preventive healthcare package.

NHIF Acting Chief Executive Officer (CEO) Dr. Samson Kuhora said, the insurer plans to work with primary health facilities across the country to strengthen preventive

health and save billions of shillings spent on treatment.

The new package, he said targets to scale up screening for cancer, diabetes and other common ailments to ensure they are detected early and managed to reduce the burden and cost of treatment.

Dr. Kuhora said NHIF spends billions of shillings annually on treatment, adding that the shift from curative to preventive

health was set to redirect the huge expenditure to other aspects of the health sector.

Most of the diseases being managed at NHIF accredited facilities, especially cancer and renal failure, he disclosed were in critical stages because of late diagnosis.

Treatment of cancer and renal failure, he said, continues to burden Kenyans with the number of cases which could have been detected early and managed rising.

The national health insurer, he disclosed, spent Sh3.8 billion on dialysis last financial year, money that could have been saved and diverted to other forms of healthcare.

“More than 40 per cent of the cases that go to end stage renal failure which

necessitates dialysis are caused by diabetes. So, by intervening early enough through proper diagnosis it will effectively reduce the number of patients who require dialysis,” he said.

In an interview, Dr. Kuhora said financing treatment had become a big challenge, adding that preventive healthcare is the way to go.

“There is a good return on investment when you intervene early enough. It is less expensive because you get the patients early enough,” he said.

The proposal, he said, has been presented to different stakeholders in government including the economic council adding that once approved, 85 per cent of Kenyans will benefit from the cover.

CS noted, "the DoDi project is being implemented by my Ministry in partnership with different stakeholders including state agencies, county governments and Indigenous Peoples and Local

Communities (IPLCs)," "By providing legal certainty and clarity, the innovation bank platform will also prevent biopiracy of our assets such as was the case with Kyondo and Kanga,"

said Malonza.

Further, she disclosed that the project is being implemented in line with the International commitment and conventions such as Convention on Biological Diversity (CBD), United Nations Educational, Scientific, and Cultural Organization (UNESCO) and World Intellectual Property Organization (WIPO) and Nagoya Protocol to mention a few.

She disclosed that the Constitution of Kenya 2010 recognizes culture as the foundation of a nation and obligates anyone accessing and utilizing its cultural heritage and intellectual assets to be fair and equitably share resultant benefits including technologies.

"The access should be through consultative and transparent process between the owners and users of the resources or knowledge under legally binding contract and mutually agreed terms," she added.

Research Institute (KEFRI) both in terms of personnel as well as equipment, to ensure that the number of seeds and seedlings needed to make the 15 billion tree campaign possible are available," she said.

CS Tuya said Kenya's national target of growing 15 billion trees in 10 years was achievable, and cited other countries in the region and across the world which had achieved similar or bigger targets including Ethiopia and Pakistan.

"Since we launched the 15 billion national tree growing restoration programme, we have met other governments and states that make our 15 billion trees in 10 years look like a drop in the ocean.

"Pakistan have on their part planted and grown 10 billion trees in the past 4 years. Ethiopia through their Green Legacy Initiative have planted over 25 billion trees," the CS noted, adding that each Kenyan need to plan 30 trees yearly to attain the target.

Health CS Calls for Global action to strengthen healthcare systems and promote equity

The Cabinet Secretary for Health Dr. Susan Nakhumicha is urging the global community to address pressing issues which are crucial to strengthening healthcare systems and promotion of equity by focusing on transformative healthcare initiatives to achieve Universal Health Coverage in the world.

She called on the global community to address the disparities in healthcare ac-

cess with an emphasis on the imperative of leaving no one behind adding that Kenya is actively implementing measures to transform its healthcare system, placing a strong emphasis on preventive and promotive measures alongside curative interventions. with the aim of strengthening the health workforce and

ensure that healthcare services are accessible and effective, particularly at the community level.

"To ensure sustainable funding and prioritize the most vulnerable populations, the Kenyan government is conducting a comprehensive review of the health financing architecture. The country is also committed to enhancing the local manufacturing of essential health commodities, thereby improving their accessibility and affordability.

Moreover, Kenya is harnessing the power of digital technologies to enhance healthcare service delivery, promote transparency, and ensure accountability throughout the supply chain pipeline system.

Dr. Nakhumicha's address at the World Health Assembly shed light on the outcomes of recent regional meetings, emphasizing the urgent need for investments in primary healthcare, digital health, mental health services, and pandemic preparedness which are

crucial for achieving UHC and strengthening health security.

Nakhumicha reiterated Kenya's commitment to reforming the multilateral system and collaborating with international partners, including the World Health Organization(WHO), to address pressing global health challenges and called upon world leaders to demonstrate the necessary political will, commitment, and resource allocation required to create a future where health for all is a reality.

Gov't, international seed producers to start irrigated potato farming in ASALS

The Government is working on modalities of increasing potato production countrywide by encouraging farmers to grow the crop in Arid and Semi-Arid (ASALS) areas like Marsabit and Wajir counties through irrigation.

The State Department of Crop Development Principal Secretary Kello Harsama said with potato being the second most consumed food stuff in the country, the government will go out of its way to increase its production so that it can replace maize which is the number one consumed food in the country.

Speaking at Kilimo House, the Harsama said the youth have driven the demand for potato to all-time highs as chips (French fries) are in high demand in colleges, universities, urban centers and homes hence the need to increase production to meet this demand.

"With the governments' drive to construct dams across the country in high gear, we want to capitalize on the availability of the wa-

ter to introduce irrigated potato farming in the arid and semi-arid areas where the people are predominantly pastoralist and introduce them to potato farming since it is a fast-maturing crop," said Harsama.

The PS said they are also going to enforce laws and regulations in the potato sector especially

the ones touching on the packaging where farmers are exploited by middle men.

"When I was the Director General at the Agriculture and Food Authority (AFA), I enforced the regulations that potatoes must be packaged in 50 kilograms bags," said Harsama, adding these regulations must be enforced in all potato-producing areas by the national government in collaboration with the respective county governments and security teams.

Harsama noted that they have instituted changes in an effort to streamline the operations at the relevant

government agencies where there is a new Director General and a new director for food crops at AFA.

"These changes are geared towards streamlining efficiencies and to ensure that regulations guiding various food sectors are fully enforced," said Harsama.

"There are very heavy fines associated with breaking these laws, those who break them risk imprisonment of up to one year, up to Sh500,000 fine or even a possibility of both a fine and imprisonment," the PS warned.

Kenya selected as host for 2026 World Potato Congress

The World Potato Congress Inc. has chosen Kenya as the host for its 2026 World Potato Congress.

The State Department of Crop Development Principal Secretary (PS,) Kello Harsama said this will be the first time this globally significant biennial business event will be held in Sub-Saharan Africa, with the event expected to draw potato industry colleagues and partners from all over the world.

Speaking from Kilimo House, Harsama said the successful bid led by the National Potato Council of Kenya and Ministry of Agriculture and Livestock Development, was supported by the Council's many public and private sector partners including but not limited to: International Potato Centre, Agriculture and Food Authority (AFA), Kenya Agricultural and Livestock Research Organization (KALRO), KenInvest, Pest Control Product Board, Kevian Kenya Ltd, Corteva AgriScience, Agriculture Sector Network (ASNET), Bayer East Africa and Syngenta Foundation for Sustainable Agriculture.

The PS said that potatoes are the second most important food crop in Kenya after maize and plays an important role in food security, poverty eradication, and economic development, yet Africa faces a great

challenge with food security as population growth continues at a fast pace.

He added that the potato crop has substantial room for improved yields, better utilization and increased incomes along the whole value chain. "Holding the Congress in Kenya will contribute towards ending extreme poverty in all forms by 2030 in Africa besides contributing towards ending hunger, achieving food security and improved nutrition and the congress will provide valuable educational opportunities in promoting sustainable agriculture," Harsama explained.

The PS said Kenya prides itself as a mature and vibrant hospitality industry with a globally renowned world class chain of hotels, offering first class conference and accommodation facilities.

Harsama said the country has an established information and communication (ICT) infrastructure, which is among the leading in the continent in terms of coverage and network connectivity in sea, road and air transport.

He noted that the 2026 World Potato Congress is expected to attract over 1,000 delegates in Nairobi for the week, stimulating the local tourism economy.

Kenya enhances campaign for Karigithu's candidature for IMO Secretary General post

Kenya's bid for the International Maritime Organisation (IMO) Secretary General post has gone a notch higher after Mining, Blue Economy and Maritime Affairs Cabinet Secretary Salim Mvurya travelled to Europe to drum up support for the candidature of Africa's nominee for the post Ambassador Nancy Karigithu for the elections scheduled for July this year.

Mvurya took the campaign for Ms Karigithu to the international fora when he launched her candidature at a hugely successful event held at IMO headquarters in London.

The campaign in London came hot on the heels of a similar event held in Nairobi earlier where CS Foreign Affairs and Diaspora Affairs Dr. Alfred Mutua officially announced the endorsement

and re-affirmation by President William Ruto of Amb. Nancy Karigithu as Kenya's and African Union candidate for the post.

"Kenya is presenting the candidature of Amb. Karigithu to progress the good work of the organization, to make the organization adopt to the world as it evolves and to address the challenges and opportunities in the Maritime and Shipping Sector," CS Mvurya told Ambassadors, Permanent representatives

to IMO and other dignitaries who attended the event .

Flanked by the PS, Shipping and Maritime Affairs Mr Shadrack Mwadime, the CS noted that through Amb. Karigithu, Kenya has had a long standing relationship with IMO which has informed many IMO activities, including ratification of more than 30 IMO conventions that are now being actively implemented.

He said 2023 was an important year for Kenya since

it marks 30 years since Kenya joined the IMO. "It therefore provides an opportunity for the IMO and Kenya to reflect on our journey in the last 50 years and to look to the future with hope and determination".

Currently, according to the CS, the UN body in charge of Global Maritime and Shipping Industry is addressing major issues that include automation of shipping, digitization and decarbonization. "It is the view of Kenya that IMO will continue to be the platform on which these issues will be agreed upon with Amb. Karigithu as the Secretary General."

On behalf of the Kenya Government, the CS called on IMO council to elect Amb. Karigithu as the next IMO Secretary General. If elected, she will be the first female Secretary General to lead the organization since it was formed 70 years ago.

Marginalized areas in Narok to receive equalization funds

Some eight nine sub-locations in Narok County which have been categorized as marginalized areas will benefit from the Third Policy of Equalization Fund.

Commission of Revenue Allocation (CRA) Chief Executive Officer (CEO) James Katule said, the sub-locations were identified from the data provided by the Kenya National Bureau of Statistics (KNBS) collected in the 2019 census that ranked the villages as marginalized.

Katule said the Commission used five parameters to measure the extent of marginalization which include the availability of water, electricity, roads and health facilities as enshrined in the Constitution, adding that recently, the Commission added education as the fifth parameter.

The CEO, who led a team from his office for a four-day fact-checking in the county said out of 185 sub-locations in the County, 89 were ranked in quantile one as the most marginalized areas, 74 sub-locations ranked in quantile two, 17 ranked in quantile three, while

four sub locations were ranked in quantile five.

"There is no sub-location that was ranked quantile five in this county, meaning no sub-location met all the basic requirements that are enshrined in the Constitution," he said.

The CRA team met several focus groups from the sub-counties which confirmed that the sub-locations identified to benefit from the funds were actually marginalized.

The commission also took views from the residents on the neediest sub-locations that had not been mentioned among the 89 sub-locations.

At the same time, the team from CRA toured various projects that had earlier benefited from the Equalization Fund projects, to verify whether the projects were benefiting the residents.

Some of the projects visited is Olchoro Dispensary in Narok Central Sub- County, which was funded to a tune of Sh4.2 million in the Financial Year 2017/2018 and Sh28 million in 2018/2019 that was used to drill a borehole and build staff houses. By Ann Salaton(KNA)
