- 1. The Government of Republic of Côte d'Ivoire has received a Loan from the Export-Import Bank of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea in the amount of USD 110,358,000 toward the cost of the construction and equipment of the National Radiotherapy and Medical Oncology Center (CNROM) Project and intends to apply a portion of the proceeds of this loan to payments under the contract for the construction and equipment of the National Radiotherapy and Medical Oncology Center (CNROM) Project.
- 2. The Ministry of Health and Public Hygiene (MSHP), as the Project Executing Agency, request sealed bids from eligible candidates who meet the qualifications required to perform the following services: Design, Construction, Medical equipment and Hospital information system (HIS), Education / training of staff, Maintenance over three (03) years and Commissioning of the national radiotherapy and medical oncology (CNROM).
- 3. The contract will be awarded as per ITB 14.2.
- 4. The services, which are the subject of this international invitation to tender, will be carried out in a single batch
- 5. Summary of CNROM (For reference only)
 - Site Location: Ilot 89, Moossou Extension, Commune de Grand-Bassam, Cote d'Ivoire
 - Site Area: 4.91 ha
 - Gross Floor Area: 17185.27 m²
 - No. of Beds: hospitalization 200 beds and ICU 18 Beds
 - No. of Floors: 1 Basement + Ground Floor+2 Floors

- 6. Bidding will be conducted through Competitive Bidding (CB) procedure single-stage and twoenvelope specified in the Guideline for Procurement under EDCF Loans, and is open to all eligible candidates that meet the following qualification criteria.

(a) For all bidders

(i) A candidate, and all parties constituting the consortium, shall have the nationality of Republic of Korea.

- (ii) All pending litigation shall be treated as resolved against the candidate, and so shall in total not represent more than fifty percent (50%) of the candidate's net worth. (Each partner in the JVA must meet the requirement)
- (iii) Bidder's last three 3 years **(2017, 2018, 2019)** average and last year **(2019)** net worth calculated as the difference between total assets and total liabilities should be positive, respectively. (Each partner in the JVA must meet the requirement)
- (iv) Bidder in bankruptcy status to Korean Law or Act as of the submission for bid proposal of this invitation for Bids is prohibited from joining this tender.
- (v) The annual net profit shown on audit report of the Bidder shall not be in deficit during the last three [3] consecutive years. Each partner in the JVA should meet the requirement.

(b) Construction Company

- (i) Average annual construction turnover for the last three [3] years (2017, 2018, 2019) shall be at least US\$ 30,000,000 (Thirty Million US Dollars) calculated as total certified payments received for the contracts in progress or completed. In case of a JVA, at least one partner must meet sixty percent [60%] of the requirement, and the sum of all partner combined must meet one hundred [100%] of the requirement.
- (ii) Availability of or access to financial resources such as liquid assets, unencumbered real assets, lines of credit and other financial means sufficient to meet any possible cash flow requirement which may arise during the execution of the contract. In particular, there should be a certificate or letter of commitment (issuance date shall be after bid announcement) from reputable banks to the effect that the bidder has financial resources/access to a credit line of at least **USD 10,000,000** (Ten Million US Dollars) for smooth execution of the Project. In case of a JVA, at least one partner should meet not less than sixty percent [60%] of the requirement, and the sum of all partner combined must meet one hundred percent [100%] of the requirement.
- (iii) The candidate shall have experience under construction contracts in the role of contractor, which can be proved by submitting the evidence of the required general experience such as copies of contract documents, for at least the latest five [5] years **prior** to the bid submission deadline and each partner in the JVA must meet the requirement.
- (iv) Candidate should have the construction projects successfully completed in the role of contractor specified as below;
 - at least two [2] building (but not limited to hospital) construction project from or outside its country of origin for the last ten [10] years prior to the bid submission deadline, each with a value of at least US\$ 10,000,000 [Ten Million US Dollars]. (at least one partner in the construction JVA must meet the requirement);

And

• at least one [1] hospital construction projects (minimum GFA 17,185.27 m2 or 200 beds) and the projects have been successfully completed including electrical and mechanical works

outside of bidder's country of origin for at least ten [10] years prior to the bid submission deadline. (at least one partner in the construction JVA must meet the requirement);

(c) Medical Equipment Supply Company

- (i) Average annual turnover for the last three [3] years (2017, 2018, 2019) shall be US\$ 30,000,000 [Thirty Million US Dollars] or more calculated as total certified payments received for the contracts in progress or completed. In case of a JVA, at least one partner must meet forty percent [40%] of the requirement, and all partners combined must meet one hundred [100%] of the requirement.
- (ii) Availability of or access to financial resources such as liquid assets, unencumbered real assets, lines of credit and other financial means sufficient to meet any possible cash flow requirement which may arise during the execution of the contract. In particular, there should be a certificate or letter of commitment (issuance date shall be after bid announcement) from reputable banks to the effect that the bidder has financial resources/access to a credit line of at **least USD 10,000,000** (Ten Million US Dollars) for smooth execution of the Project. In case of a JVA, at least one partner should meet not less than sixty percent [60%] of the requirement, and the sum of all partner combined should meet one hundred percent [100%] of the requirement.
- (iii) The bidder shall have experience under medical equipment supplying contracts in the role of contractor, which can be proved by submitting the evidence of the required general experience such as copies of contract documents, for at least the last five [5] years prior to the bid submission deadline and each partner in the medical equipment JVA must meet the requirement.
- (iv) Bidder should have the medical equipment supplying projects successfully completed in the role of contractor specified below;
 - At least two [2] similar Medical Equipment projects (minimum contract amount US\$ 5,000,000
 [Five Million US Dollars] that have been successfully completed in the last ten [10] years prior
 to the bid submission deadline from or outside of its country of origin. In addition, at least one
 partner in the medical equipment JVA must meet the requirement.
 - At least one [1] similar Medical Equipment projects (minimum contract amount US\$ 2,000,000
 [Two Million US Dollars] including supply, installation, maintenance and training of medical
 equipment that have been successfully completed in the last ten [10] years prior to the bid
 submission deadline outside of bidder's country of origin. In addition, at least one partner in
 the medical equipment JVA must meet the requirement.
 - In this document "similar Medical Equipment project" means the project including delivery, installation, training and warranty of medical equipment which coincides with not less than 30% of the number of core medical equipment supplied for the project as the contractor and/or subcontractor. In case of medical furniture and medical consumable item supply will not be counted. Core medical equipment list will be provided separately.

(d) HIS (Hospital Information System) Supply Company

(i) Average annual turnover for the last three [3] years (2017, 2018, 2019) shall be at least US\$ 5,000,000 [Five Million US Dollars] calculated as total certified payments received for the contracts

in progress or completed. In case of a JVA, at least one partner must meet sixty percent [60%] of the requirement, and all partners combined must meet one hundred [100%] of the requirement.

- (ii) Availability of or access to financial resources such as liquid assets, unencumbered real assets, lines of credit and other financial means sufficient to meet any possible cash flow requirement which may arise during the execution of the contract. In particular, there should be a certificate or letter of commitment (issuance date shall be after bid announcement) from reputable banks to the effect that the candidate has financial resources/access to a credit line of at least **USD 500,000** (Five Hundred Thousand US Dollars) for smooth execution of the Project. In case of a JVA, at least one partner should meet not less than sixty percent [60%] of the requirement, and the sum of all partner combined should meet one hundred percent [100%] of the requirement.
- (iii) The bidder shall have experience under HIS supplying contracts in the role of contractor, which can be proved by submitting the evidence of the required general experience such as copies of contract documents, for at least the last five [5] years prior to the bid submission deadline and each partner in HIS JVA must meet the requirement.
- (iv) candidate should have the HIS supplying projects successfully completed in the role of supplier specified below;
 - At least One [1] similar HIS projects (minimum contract amount US\$ 1,000,000 [One Million US Dollars] that have been successfully completed in the last ten [10] years prior to the bid submission deadline from or outside of bidder's country of origin. In addition, at least one partner in the HIS JVA must meet the requirement.
 - In this document "similar HIS project" means the project which is successfully completed and
 fully handed over after warranty services to the Purchaser and in which the scope of contract
 and/or sub-contract includes, as its scope of contract, development as a hospital information
 system for EMR, OCS(CPOE), hospital MIS and warranty of HIS. In case of H/W or S/W delivery
 alone project without HIS development, installation, maintenance and any other customization
 will not be included.

(e) Education/Training Institute

- (i) The bidder shall have experience under medical personnel education/training contracts in the role of contractor for at least the last five [5] years prior to the bid submission deadline. In case of JVA, each partner should meet the requirement.
- (ii) Bidder should have at least one [1] project in the role of contractor in relation to training for foreign medical personnel (medical staffs/students) with a value of at least US\$ 30,000 [Thirty [30] thousand US Dollars] and has been successfully completed in or outside of bidder's country of origin for the last ten [10] prior to the bid submission deadline.
