The Government of the United Republic of Tanzania has received a Credit from the Government of the Republic of Korea, through the Economic Development Cooperation (EDCF), toward the cost of Vocational Education Training Authority (VETA) and it intends to apply part of the proceeds of this Credit to payments under the Contract for the **CONSTRUCTION OF VOCATIONAL TRAINING CENTRES' INFRASTRUCTURE AT LINDI, MANYARA, PWANI AND DAR ES SALAAM ICT CENTER**
2. The VETA Tender Board now invites sealed bids from Korean eligible and qualified bidders for **CONSTRUCTION OF VOCATIONAL TRAINING CENTRES INFRASTRUCTURE AT LINDI, MANYARA, PWANI AND DAR ES SALAAM ICT CENTER**

3. Bidding will be conducted through the Competitive Bidding (CB) Method, Single Stage Two Envelopes procedures amongst the Korean firms as specified in the Economic Development Cooperation Fund (EDCF) Guidelines for Procurement under EDCF Loans, and is open to Korean firms only registered in the Republic of Korea.

Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at 10:30 hours local time on **Friday 2nd May 2008**.
