

1. The Government of the Dominican Republic has received a Loan from the Export-Import Bank of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea in the amount of Twenty Five Million US Dollars (US\$25,000,000) toward the cost of Establishment Project of Dominican Republic Immigration Information & Management System (DRIMIS) and intends to apply a portion of the proceeds of this loan to payments under the contract for Establishment Project of Dominican Republic Immigration Information & Management System (DRIMIS).
2. The Project Executing Agency now invites sealed bids from eligible bidders for supply, transportation, delivery, installation, development, training, testing and support for maintenance and operation of the DRIMIS on a turn-key basis under the project titled "Establishment Project of Dominican Republic Immigration Information & Management System (DRIMIS)" as per mentioned scope of work in the subsequent clauses in these Bidding Documents.
3. In accordance with the Guidelines for Procurement under the EDCF Loan (as defined in Section 2.03), the Invitation for Bids (IFB) / Specific Procurement Notice (SPN) shall be advertised in English, in at least one newspaper of general circulation in the Borrower's country.
4. Bidding will be conducted through Competitive Bidding (CB) procedures specified in the Guidelines for Procurement under the EDCF Loans, and is open to all eligible bidders that meet the following minimum qualification criteria. (i) Bidders, if it is JV, all partners shall be incorporated under the laws of the Republic of Korea; and (ii) The qualification requirements shall be satisfied by the Bidder itself, if it is JV, all partners themselves only and any experiences or resources of their Affiliates shall not contribute to the Bidder's qualifications. For the purposes of this clause, Affiliates shall be defined as any company that directly or indirectly, through one or more intermediaries, controls, is controlled by, or is under common control with, the Bidder; and (iii) Bidders shall meet the qualification requirements as below.
  - i. *In the case of Joint Venture or Consortium, at least one of the participants needs to follow all of the criteria hereunder*
  - ii. *A minimum of ten (10) years' business experience record in ICT system integration field from the bid issuing date.*
  - iii. *At least one (1) successfully completed e-government project experience contracted directly with government agencies (Korea or Foreign) amounted at least 50% of their submitted bid prices and of recent ten (10) years from the bid issuing date.*
  - iv. *The bidder that has been negative in its net profit for the last three (3) consecutive years (2011 -2013) shall be treated as "Non Responsive".*
  - v. *The bidder that has been negative in its net worth for the last three (3) consecutive years (2011 -2013) shall be treated as "Non Responsive".*
5. Interested eligible Bidders may obtain further information from and inspect the bidding documents at the DGM (Direccion General de Migración) at the address given below from 09:00 ~ 17:00 hours, from Monday to Friday.
6. A complete set of bidding documents may be purchased by any interested Bidders on the submission of a written application to the address below and upon payment of a nonrefundable fee of Eight hundred US Dollars (US\$ 800) until twenty (20) days before deadline for submission of Bids. The method of payment will be cash and the document will be delivered directly to whom the Bidders purchased bidding document at the address below. No Bidding Document will be sold by post. In the case of Joint Venture or Consortium, one of the members can purchase the bidding documents. If one of the members purchase the bidding document, relevant Joint Venture or Consortium is deemed duly applied for the bidding.
7. Bids must be delivered to the address below at or before 15:00 hours on 27th of October 2014. bids must be accompanied by a bid security of at least US\$ 600,000. bids shall be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend at the address below at 16:00 hours on 27th of October 2014.
8. The attention of prospective Bidders is drawn to (i) the fact that they will be required to certify in their bids that all software is either covered by a valid license or was produced by the Bidder and (ii) that violations are considered fraud, which is, among other remedies, punishable by potential blacklisting from participation in future EDCF-financed procurements
9. All documentary Evidence should be submitted in English, and if the document is written in other language, it should be translated to English and apostilled, and should be finally submitted.
