- c. Annual net profit for the last 03 years should not show consecutive deficit respectively. In order to fulfill the commitment of two year construction and 1 year warranty, the contractor must have financial sustainability.
- d. The Bidder is in bankruptcy or court receivership or vergleich is not allowed to participate in the bidding.
- e. For the last five (5) years, Bidder should have as a contractor at least two (2) solar power projects at home or overseas. The installed solar module capacity of one of those two solar power projects should be at least 500kWp in gridtied type or 50kWp in stand-alone type. If the installed solar module capacity of 500kWp in grid-tied type, the value of at least one (1) contract should be no smaller than US eight million (8,000,000) dollars, otherwise if the installed solar module capacity of 50kWp in stand-alone type, the value of at least one (1) contract should be no smaller than US three million (3,000,000) dollars...
- f. The Bidder must have at least one project experience completed outside the bidder's country for the last five (5) years.
- g. Bids submitted by a joint venture or a consortium (JVC) shall comply with following requirements;
- (i) Each Partner of JVC shall have a minimum average annual turn-over during the last 3 years which is more than its share of the bid (proposed price) respectively;
- (ii) The annual net profit shown on audit report of each partner of JVC should not show consecutive deficit during the last 3 years period respectively.
- (iii) Any partner of JVC in bankruptcy or court receivership or vergleich is prohibited from joining this Bidding.
